

## Cookie Policy

### Introduction

1. Please read this cookie policy (**Cookie Policy**) carefully as it contains important information on who we are and how we use cookies on [www.weteachdrama.com](http://www.weteachdrama.com), all associated sub-domains, web-apps and mobile apps (**Website**). This policy should be read together with our Privacy Policy which sets out how and why we collect, store, use and share personal information generally, as well as your rights in relation to your personal information and details of how to contact us and supervisory authorities if you have a complaint.

### Who we are

2. This Website is operated by We Teach Drama Ltd, a teaching resources service provider.

### Our Website

3. This Cookie Policy only relates to your use of our Website.
4. Throughout our Website we may link to other websites owned and operated by certain trusted third parties to make additional services available to you. These other third-party websites may also use cookies or similar technologies in accordance with their own separate policies. For privacy information relating to these other third-party websites, please consult their policies as appropriate.

### Cookies

5. A cookie is a small text file which is placed onto your device (for example your computer, smartphone or other electronic device) when you use our Website. We use cookies on our Website. These enable the Website to function fully, help us recognise you and your device and store some information about your preferences or past actions and optimise your experience of the Website.
6. For example, we may monitor how many times you visit the Website, which pages you go to, traffic data, location data and the originating domain name of your internet service provider. This information helps us to build a profile of our users and help you engage the service providers that suit you best. Some of this data will be aggregated or statistical, which means that we will not be able to identify you individually.
7. Cookies may be either "persistent" cookies or "session" cookies. A session cookie expires when you cease accessing the Website and close the web browser window, whereas a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted earlier by the user.
8. Cookies may not contain any information that personally identify you on its own. However, this information, like your physical IP address, may be linked to other information that we process on your behalf which would enable identification.

9. All Cookies used by this Website are used in accordance with current UK and EU data protection laws.
